# **COVID-19 Emergency Maintenance Technician**

## Temporary position in response to the COVID-19 pandemic

The CTGR COVID-19 Emergency Maintenance Technician will be responsible for keeping equipment and facilities in operating condition and will be responsible for performing a wide range of maintenance tasks as needed. The position pays an hourly rate of \$22 to \$25 per hour, up to 32 hours per week, depending upon experience. The position will be filled based on need for a period of *up to* one year.

### **Duties and Responsibilities**

- 1. Oversee the supply of chopped wood to ensure that CTGR members on the Reservation are adequately prepared for the winter season
- 2. Track inventory of equipment and tangible assets on the reservation (vehicles, freezers, generators, etc.)
- 3. Drive to surrounding cities and towns to obtain supplies, including but not limited, to personal protective equipment, food items, emergency household goods, equipment, etc.
- 4. Maintain delivery vehicles including but not limited to driving them to town for oil changes, tire repairs, windshield replacement, etc.
- 5. Assess broken equipment and report recommended repairs to the Budget Committee including but not limited to appliances, vehicles, fuel tanks, generators, etc.
- 6. Assist in loading and unloading heavy equipment and shipments that arrive on the Reservation
- 7. Support the Food Pantry by delivering items to members as needed
- 8. Provide maintenance support to the CTGR Meat Processing Facility and deliver and pickup supplies and/or other items as needed.

### Required

- 1. A valid driver's license
- 2. Ability to operate a forklift, heavy equipment, and delivery vehicles
- 3. Ability to lift heavy objects (up to an estimated 50 pounds)
- 4. Knowledge of vehicle maintenance is helpful
- 5. Must have good communication skills to provide accurate updates and information to the Budget Committee

This is an equal opportunity employment position. Open to anyone interested in outdoor/indoor active working conditions.
